Fresh Is Always Better

WEST SACRAMENTO, CA (MPG) - To reduce barriers to food insecurity in West Sacramento, the Mobile Farmers Market from the Center for Land Based Learning (CLBL) hosts multiple stops in the area, providing

locally grown produce to residents in areas with little access to fresh food, commonly referred to as “food deserts.”

The Mobile Farmers Market targets low-income and low-access areas for fresh and healthy foods, setting up shop outside of communities, parks and senior centers.

Susie Sutphin, the community food program manager at the Center for Land Based Learning, said the mobile market is in its fifth season and has had the opportunity to help residents and farmers by providing a marketplace for them to move their produce. The mobile marketplace

I Street Bridge Replacement has 2026 Construction Start

SACRAMENTO/WEST SACRAMENTO, CA (MPG) - The City of Sacramento is moving one step closer to breaking ground on the long-anticipated I Street Bridge Replacement Project, a transformative effort that will replace the existing 113-year-old bridge with a new multimodal crossing linking Sacramento and West Sacramento.

Sacramento city staff presented an update on the project’s funding and financing strategy at the July 29 Sacramento City Council meeting.

The update outlined major progress toward construction in 2026, thanks to recent commitments of state and federal funding and ongoing efforts to finalize interagency financing agreements.

The project has benefited from strong and sustained leadership at the

local, state and federal levels. U.S. Congresswoman Doris Matsui has championed the project from the beginning, even proposing the architectural design competition that helped shape the bridge’s final look.

State Senators Angelique Ashby and Christopher

Cabaldon have also played key roles, advocating for funding and interagency collaboration.

“This is not just a bridge; it’s a once-in-a-generation investment in connectivity, safety and opportunity for both cities,” said Assistant City Manager Ryan Moore. “We’re deeply grateful to

all of our local, regional, state and federal partners who continue to work alongside us to bring this vision to life.”

The replacement bridge will feature 12-foot shared-use paths for pedestrians and cyclists, wider travel lanes to accommodate

Yolo County Nut Buying Starts

YOLO COUNTY, CA (MPG) - Yolo County Agricultural Commissioner Humberto Izquierdo recently announced that the nut buying period began Aug. 1 and will run through next April 1, in accordance with the county’s nut theft ordinance.

On May 13, 2014, the Yolo County Board of Supervisors adopted a nut theft ordinance to assist with the issue of nuts being stolen from orchards and illegally sold.

The declaration of the nut buying period and related Proof of Ownership requirements assists the department in enforcing the ordinance through compliance checks at places where nuts are sold.

During this period, individuals in possession of unprocessed “nuts” (almonds, walnuts and/or pistachios) shall be required to show a proof of ownership.

Under probable cause, the agricultural commissioner or any peace officer can inspect the commodity and request that Proof of Ownership be provided containing the name, address, telephone number and signature of the seller and buyer; the vehicle license plate number of the seller; the driver’s license number of the seller; the weight of the “nut” commodity purchased; the date and time of the transaction; the variety and condition of the “nut” commodity and specific identification of the source of the commodity being sold.

If the seller is the grower of the commodity, this shall mean the address at which the commodity was grown. If the seller is not the grower of the commodity, this shall mean the name, address and phone number of the person from whom that seller obtained the “nut” commodity, and if known, the address where the commodity was grown.

The Proof of Ownership shall be retained with the nut commodity to which it pertains while the commodity is in any person’s possession.

Forms can be obtained from the Yolo County Agriculture Department, located at 120 West Main Street, Suite D., Woodland, or at the Yolo County Farm Bureau, located at 69 W. Kentucky Ave. in Woodland. ★

buses and emergency vehicles, and improved connectivity to trails and regional destinations.

The existing I Street Bridge, built in 1911, will remain in place but be converted into a bicycle and pedestrian-only crossing on its upper deck.

Construction of the new bridge is estimated to cost \$300 million. Caltrans (California Department of Transportation) has committed \$250 million in federal Highway Bridge Program funds

toward construction and the California Transportation Commission awarded an additional \$25 million in competitive state funding earlier this summer.

The City of Sacramento is continuing to work with its partners to finalize key financing arrangements that will support the project’s construction phase. Key next steps include presenting the financing strategy to the Sacramento Transportation Authority this month and submitting a final finance plan

to Caltrans. The City of Sacramento is also working with the City of West Sacramento to finalize cost-sharing agreements, with each city expected to contribute between \$13 million and \$32 million, depending on the final financing structure.

These agreements will require further Sacramento City Council review and approval, expected in September.

Construction is expected to begin in spring 2026 and take approximately four years to complete. ★

runs from May 13 to Nov. 20.

"We do operate two mobile market trucks throughout Yolo County, so we have 11 stops Tuesday through Thursday in West Sacramento, Woodland, Esparto and Knights Landing," Sutphin said.

Alyssa Himenes, a farming and marketing assistant intern, said she is going into her junior year at Washington Middle College High School and completed an eight-week summer internship helping to sell, weigh, bag and assist customers at the marketplaces.

The Center for Land Based Learning has a farm in West Sacramento where 30 to 40% of the produce is grown for the mobile market. Its farmstand is open from 9 a.m. to noon Fridays at 985 Riverfront St. in the Bridge District.

"The rest of the produce comes from the other local farms here in West Sacramento and some from Woodland too," Himenes said. "Woodland has our headquarters for CLBL, so we get from other farms from there as well."

Himenes said she also helps with farm maintenance, seeding, harvesting, weeding and trellising, a gardening technique using supportive structures. While her eight-week internship is ending and school starts in mid-August, Himenes said she plans to stay connected with the Center for Land Based Learning because she has "grown an intense passion" for planting, agriculture and environmental science.

"I want to go to UC Davis," Himenes said. "UC Davis is my dream. In fact, we have a lot of UC

Davis interns that work at our farm."

The Center for Land Based Learning is a nonprofit organization, operating for more than 30 years. The mobile market is a certified vendor with a state-funded program called Market Match and also receives funding from Supplemental Nutrition Assistance Program (SNAP).

The Center for Land Based Learning is a partner with CommuniCare+OLE, a health care group committed to providing quality health care services, regardless of a patient's ability to pay. Sutphin said that CommuniCare+OLE provides a produce prescription program with \$1 "food is medicine" vouchers.

The Mobile Farmers Market accepts cards, cash and EBT. Sutphin said the selection is seasonal, local, sustainably grown and affordably priced. EBT customers automatically receive 50% off their purchase, regardless of if there are enough funds on the card, meaning the cash price is still 50% off for EBT customers, she said.

Assisting community members with access to resources, translations and other needs at the marketplace was Sardar Safi, the Health Education Council community health leader, and other council members. The Health Education Council is a regular partner with the mobile market, hosting information tables at their stops.

Safi said that he and the Health Education Council staff can see about 50 people on a given day, providing them with fliers, pamphlets and other information about events, programs and campaigns

that can assist them. The events can range from youth soccer to food distribution, medical resources to arts and crafts.

The Health Education Council also conducts safety surveys within the communities it stops at and relays the findings back to the residents, according to Safi.

The Mobile Farmers Market is scheduled to be in West Sacramento at the Valhalla Mobile Home Community, located at 3901 Lake Road on Tuesdays from 9:30 to 11 a.m. and the Margaret McDowell Manor at 1525 Merkley Ave. from noon to 2 p.m. On Thursdays, the marketplace is scheduled to be at Bryte Park on the corner of Holland and Carrie Street from 9:30 to 11 a.m. and the West Capitol Courtyard Apartments, located at 2455 West Capitol Ave. from noon to 2 p.m.

In Woodland, the market will be at the Courtside Towers Apartments, located at 320 West Court St. from 9:30 to 11 a.m. and the Yolo Adult Day Health Center, located at 20 N. Cottonwood St., from noon to 2 p.m. on Wednesdays.

The market will be at the Leisureville Mobile Home Park, located at 1313 E Gibson Road in Woodland from 9 to 11 a.m. and at Knights Landing, on the corner of 4th and Locust Street in Knights Landing from 12:30 to 2 p.m. on Thursdays.

On Fridays, the farmstands will be open at the Esparto Community Park at 17001 Yolo Ave. in Esparto from 9 to 11 a.m. and at the Boys & Girls Club, located at 433 W Cross Street in Woodland from 12:30 to 2 p.m. ★

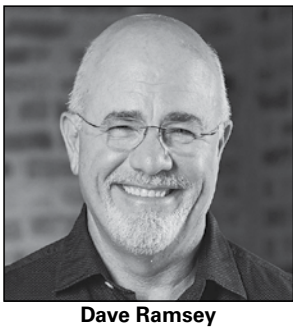

Peach Growers Praise Fruit Quality as Yields Dip

Mild temperatures in the Central Valley were kind to peaches used for canning this month as farmers harvested their early varieties. "The quality of the fruit is looking really good," Sutter County farmer Chetan Khera said. Growers were projected to supply around 224,000 tons of cling peaches to canneries this year, the California Canning Peach Association estimated, a slight reduction from last year. However, the association reported that early yields were down roughly 12% from initial estimates. Last summer's extreme heat and an unusual bloom pattern this past winter and spring "may have hurt some of our production," said Thomas Gradziel, professor of plant sciences at the University of California, Davis.

Federal Forestry Cuts Fuel Wildfire, Resource Concerns

With wildfire conditions in California expected to increase in coming months, state officials expressed concerns about cuts in staff and funding at the U.S. Forest Service, a division of the Agriculture Department that partners with the state to fight wildfires and manage forests. The proposed federal budget for fiscal year 2026 includes a reduction in Forest Service spending, including for fire suppression. "The key is we need to scale up across the board if we are going to meet our targets and keep our communities safe," said Patrick Wright, executive director of the California Wildfire and Forest Resilience Task Force. "This causes real concern in the federal ability to step up and meet our joint targets."

California's Fresh Apples Compete Against Old Washington Fruit

Harvest of Gala apples—the earliest commercial variety to arrive in stores—has started in the Central Valley, with the fruit hitting produce aisles this week. Because California starts picking apples several weeks before Washington state—the nation's leading producer—providing the first fresh apples of the year is a key selling point. "As foreign imports start to drop off, last year's fruit from the Pacific Northwest will remain the only competition for the start of the season," said Todd Sanders, executive director of the California Apple Commission. Unlike the Evergreen State, which keeps its apples in cold storage and sells them long after harvest ends, apples from the Golden State are picked, packed and shipped fresh.

On The Record: Ricardo Lara Discusses California's Insurance Crisis

California Insurance Commissioner Ricardo Lara spoke with Ag Alert® this month about the state's insurance crisis and his strategy to stop insurance companies from leaving California and restore access to property insurance for farmers and rural communities. California's Sustainable Insurance Strategy allows insurers to use catastrophe modeling to better assess modern-day risks—and to pass along the rising cost of reinsurance—in exchange for committing to expand insurance access in high-risk areas. "Our job is to make insurance more available, reliable and fair, especially for those in high-risk, rural areas," Lara said. "I want farmers to know that we are fighting for them and that we're not going to stop until we fix this crisis." ★

Trio of Hornets Taken on Day Two of Major League Baseball Draft

Sacramento State Athletics News Release

SACRAMENTO, CA (MPG) - Three Sacramento State baseball players were selected on day two of the 2025 Major League Baseball Draft on Monday, as right-hander Carson Latimer (Cincinnati), infielder JP Smith (Minnesota), and right-hander Kade Brown (Athletics) were among the 615 players chosen overall during the league’s two-day event.

This year’s trio becomes the 30th, 31st, and 32nd Hornets either to be drafted or to sign a professional contract with a Major League club under Head Coach Reggie Christiansen since 2011 and marks the 19th consecutive season that a Sacramento State baseball player has been drafted or signed since 2007.

Taken with the 354th overall pick in the 12th round, Latimer became the highest drafted Hornet since Travis Adams (sixth round) and Scott Randall (seventh round) were top-10 round selections in 2021 and is the seventh Sacramento State player drafted by the Reds in program history, the first since infielder Ray Brown was selected in the 28th round in 1994.

In his first season with the Hornets, Latimer made 15 appearances on the mound and started seven games for Sacramento State, finishing 2-3 overall with 28 strikeouts in 36.2 innings of work. He struck out a season-high five in

three innings against Abilene Christian on April 5 and had four more strikeouts in three innings against UT Arlington on March 22. Against California Baptist on April 18, he allowed just one hit over four shutout innings, striking out three Lancers.

Smith was selected with the 509th overall pick in the 17th round by Minnesota and became only the fourth Hornet to be drafted by the Twins in program history joining Tanner Mendonca (17th round in 2013), Tyler Beardsley (16th round in 2016), and the aforementioned Adams, who made his Major

League debut earlier this month and picked up his first career victory on July 12.

A first-team All-Western Athletic Conference selection for the second time in his career in 2025, Smith finished the campaign hitting .291 while starting all 58 games, scoring 42 runs, collecting 18 doubles, and slugging 12 home runs to go along with a team-high 52 RBI. He ranked in the top 15 in the WAC in hits (t12th), RBI (t8th), doubles (6th), home runs (t9th), and total bases (10th).

Brown became the third Sacramento State player selected

on Monday, taken by the Athletics in the 20th round (590th overall). It marked the second straight year that the Athletics drafted a Hornet after taking infielder Gunner Gouldsmith in the 19th round in 2024, while Brown became the ninth Sacramento State player to go from Hornet green and gold to Athletics green and gold.

A third-team All-America selection and finalist for the “Stopper of the Year” by the National Collegiate Baseball Writers Association, Brown was a first-team All-Western Athletic Conference selection in 2025, finishing 3-2 on the mound

with a 2.93 ERA, posted 49 strikeouts over 43 innings of work, and held opponents to a .204 average. A three-time All-WAC selection during his career and the school’s all-time leader in home runs with 48 over his three seasons, Smith ranked in the top 15 in the WAC in hits (t12th), RBI (t8th), doubles (6th), home runs (t9th), and total bases (10th) this past year.

The Hornets’ three draftees this year mark the first time since 2019 that three Sacramento State players were selected in the same season when Austin Roberts was picked by Pittsburgh in the eighth round, Tanner Dalton was selected by the Chicago Cubs in the 17th round and Parker Brahms was drafted by the Los Angeles Dodgers in the 27th round.

It also represents the first time that three Sacramento State players were drafted in the top 20 rounds since 2003 when right-hander Chris Kinsey was selected by Arizona in the fourth round, Jesse Schmidt was taken in the 10th round by San Francisco and Mikela Olsen was take in the 15th round by Florida (now Miami).

In all, 10 former Hornets have appeared in a Major League game in the history of the program with five of them currently active on MLB rosters (as of July 14): Rhys Hoskins (Milwaukee), Nathan Lukes (Toronto), Sam Long (Kansas City), James Outman (Los Angeles Dodgers), and Adams (Minnesota). ★

DAVIS, CA (MPG) - Rex Connors and Hunter Ridley took home first team honors to lead the way for UC Davis football’s five members on the FCS Football Central Preseason All-American list, with Winston Williams, Jacob Psyk and Porter Connors earning the honors.

Williams and Psyk were named to the second team while Porter Connors earned a third team nod. The Aggies were tied for the third-most members on the team joining fellow Big Sky Conference member Montana State, North Dakota State and South Dakota.

Rex Connors adds to a quickly filling trophy case with this being his second Preseason All-American honor this season having earned the nod from STATS Perform. The Aggie defensive back was also named the Big Sky Preseason Defensive Player of the Year (the first Aggie to earn that honor) and earned Preseason Big Sky All-Conference honors.

His 2024 All-American season was record-breaking finishing with a program record 74 solo tackles, finishing with a total

tally of 115 on the season.

Ridley has had a busy summer of accolades, earning STATS Perform Second Team Preseason All-American honors along with being named Big Sky Preseason All-Conference. The Aggie primary kicker was also nominated for the 2025 Allstate AFCA Good Works Team. He was named a 2024 Fred Mitchell Award finalist after going 16-for-18 in field goals and hitting 56 PATs during the 2024 campaign.

Williams, who has already earned STATS Perform Second Team Preseason All-American and Big Sky Preseason All-Conference honors was also named the second-best returning tight end in the nation by HERO Sports.

He ended the 2024 season leading all Big Sky tight ends in touchdown receptions and he finished second in the nation for most receiving touchdowns by a tight end. When the year came to an end, Williams had racked up career numbers finishing with 265 receiving yards on 34 receptions, snagging six touchdowns while averaging 19.0 yards per game.

Psyk joined the Aggies during the

offseason as a transfer after four seasons at Harvard. During his senior season Psyk was named All-Ivy League first team following a year where he ranked 29th in the nation in sacks, finishing with 26 tackles, 6.5 sacks, one forced fumbled and one recovery.

Porter gained STATS Perform Third Team Preseason All-American honors to go along with a Preseason Big Sky All-Conference nod. During the 2024 season he finished with 86 total tackles, made three interceptions and scored a defensive touchdown on a scoop and score in the season opener at California. His game at Cal earned him national defensive player of the week honors as the Aggie line-backer would go on to start 13 games over the remainder of the season.
