SACRAMENTO, CA (MPG) - What is home? For many of us, we will say an address or point to a neighborhood on a map. We might say home is someone or something familiar we are fortunate enough to keep returning to. But for hundreds of foster kids in Sacramento County, a home can be much harder to define and

belong in – particularly one where they feel like they fit in. More than ten years ago, Britney and Erin Eason decided they would become a home for both children and teens who needed a safe space to feel accepted and loved. Sitting on their couch one summer afternoon, surrounded by three very talkative tweens, a babbling baby and one quieter child – Britney and Erin shared their journey to

becoming resource parents in Sacramento County. “People will always say, ‘the kids are so lucky to have you,’ and that’s not it. We are lucky to have these kids. They are going through the hardest time of their lives. They are not lucky. They’re picked up, swooped up and they’re put in a stranger’s home,” Erin said. “Maybe a really cool stranger’s home with some really cool pets, but we’re

still strangers, right?” Britney added, gesturing at their home filled with animals – including an iguana, one cat, several spiders and two very friendly Irish wolfhounds. Britney and Erin said what many people might not realize is even in a supportive foster home, kids and teens will face challenges many of us may never think about. “We have different

SACRAMENTO COUNTY, CA (MPG) - Sacramento County’s updated Crowing Fowl Ordinance will provide clearer standards for keeping roosters in unincorporated Sacramento County while strengthening protections for both animals and the community. The ordinance is designed to support responsible rooster ownership, improve animal welfare, reduce nuisance conditions and help deter illegal cock-fighting. For Sacramento County Animal Care Services, the ordinance is also an opportunity to educate the public about the work Animal Control officers perform every day. More Than a Noise Complaint When residents hear about rooster-related calls, many assume they’re simply responding to complaints about early morning crowing. While noise complaints are one reason officers may be dispatched, Animal Control officers are trained to assess much more than sound. During an investigation, officers evaluate the overall health and welfare of the animals, including whether they have access to adequate food, clean water, appropriate shelter and safe living conditions. They also look for signs of neglect, overcrowding or injuries that may require intervention.

A Teen’s Story of Survival in Wartime

SACRAMENTO, CA (MPG) - At the beginning of the summer of 2026, in Sacramento’s Greenhaven/Pocket neighborhood, Jane Gallagher began contacting friends by email. Her message was: “I hope you can help my brother and me launch ‘Janina’s War: How a Teenager Survived Nazis, the Resistance, and the Most Horrific War on Earth,’ written by Jalynn Venis (our cousin). “Janina was our mother, and a hero, along with my grandparents, aunts and uncles, who survived. I know you’ll find her story amazing and inspiring. “It was our mother’s greatest wish that this story would be told! After almost 15 years of compiling our mother’s story, Kevin, my brother, and I are happy to send this first notice for the book launch.” Near the end of World War II, Janina met Charles Clark, a United States soldier. Janina and Charles married soon after the war ended in Germany. Their daughter, Jane, has photographs from their wedding. One photograph shows a mother and

foods, different rules, different smells. They don’t have their favorite blankets or their favorite stuffies. They don’t have the clothes that they like to wear. They may have to change schools. We try to keep them as plugged in as possible, but they may have to,” Britney said.

“When we moved into this house, a bigger house, our goal was to have more kids in general,” Britney, a resource parent said.

While fostering comes with challenges, Britney and Erin say they would not change this incredible journey. The couple became resource parents when there was a need to provide a home to a relative’s child – their now-adopted daughter Leilani. Since then, they’ve helped provide a home for more than 40 children and teens in foster care, and they have adopted five of the kids who came into their care.

“I like that both of my moms are very passionate about what you love and, like, the activities that you’re into,” Leilani said.

Once Britney and Erin became licensed resource parents through Sacramento County, they felt called to continue helping kids, even eventually moving to a larger home so they could foster additional children.

“When we had our license, our initial goal, moving from the smaller house into this house, was to be able to have more kids in general. But once we got here, we realized there was a big need for sibling sets. So that was kind of how we started, was getting, like, sibling sets of, like, two to five,” Erin said.

Erin’s reference to “sibling sets” refers to Sacramento County’s efforts to keep siblings who are removed to be placed in the same home as often as possible. It can be challenging to find resource homes for sibling sets, as some licensed parents may not have enough space or may already be fostering other children.

“When I met Erin, that kind of changed my life,” Jalen, a former foster youth who lived with Britney and Erin said. “We left our license open from zero to 18, so we eventually started getting calls for teenagers,” Britney said.

When Britney and Erin began fostering, they wanted to stick with children because of fears over safety issues since Leilani was young at the time. That mindset stuck – until Erin went to meet 15-year-old Jalen.

“I had something going on, and so I wasn’t there, but she came back [from meeting Jalen], and she was like ‘yep, that’s my kid,’” Britney said.

Jalen is now in his 20s, and he keeps in touch with Britney and Erin through video calls and comes over for dinner.

“I think I was 15 going on 16, so around 2015. It was around that time that I met Erin. I was at the receiving home at that time, and I was going in and out of the receiving home,” Jalen said.

The Children’s Receiving Home provides temporary congregate placement for foster youth who are waiting on a resource parent or relative placement. Many of the youth they serve are teens. And for Jalen, a gay teenager – finding an understanding home over a decade ago was challenging.

“I was very persistent in advocating for myself to get a home because I didn’t want to stay in the dorm for too long,” Jalen said.

Jalen represents a large number of foster kids in Sacramento County. According to data, more than a third of children in foster care identify as LGBTQ+. But Jalen said that shouldn’t matter – resource parents should accept children no matter what. Jalen says he will never forget meeting “mama Erin” for the first time and how she immediately accepted him for who he is.

“When I met Erin, that kind of changed my life.”

Jalen felt so happy in his new home – that he wanted to share that love.

He met foster teen Lottie at school – he said he could tell she was going through a difficult time and approached her.

“I was going to a new school. We had class together, and I was quiet. I was just kind of, like, living day by day, just trying to figure out what I’m doing the next day, how I’m surviving, all the things. And so, he came up to me and kind of burst my bubble,” Lottie said.

The teens started talking about their pasts and living situations – quickly becoming friends.

“So, one day I was just like, ‘Can I meet your moms? Like, I want to know,’ like, it sounded so good, I just didn’t believe it, so I was like, ‘I want to meet you. I want to see this,’ Lottie said. “And so, um, he went back and told them about me, and then one day, uh, Mama Brittany was coming up in the truck, and I was like, ‘Hey,’ like, ‘I want to move in with you,’ like, ‘Can I be your new daughter?’”

Eventually, Lottie made the move into Erin and Britney’s home. She is now in her 20s and has a child of her own. She still keeps in touch with the Eason family – and they continue to support her by offering advice as seasoned parents and by being the occasional babysitters for Lottie’s child.

The Eason family fosters through Sacramento County’s Department of Child, Family and Adult Services. They said the resources and classes provided by the County helped build their confidence as parents.

“We’re able to find whatever supports are necessary – whether it’s educational, mental health, physical health, whatever it may be, we’re able to really get peer mentors, family advocates, whatever we need and whatever the kids need,” said Brittany.

As of July 2026, more than 800 kids and teens were in foster care in Sacramento County. Many

of the youth placed in foster care are in supportive homes – but some are still waiting for placement. 887 is the exact number of kids in Sacramento County Foster Care as of July 1. On average, 15 kids are usually awaiting placement. Britney and Erin are aware of the need for more resource families and said they always start conversations about how others can get involved – even when they’re meeting strangers in public.

“I tell strangers that I meet if they come up and talk about our kids ... that they can just contact the county. Get set up with orientation. It doesn’t cost anything. It’s free. Just go down there, ask questions,” Erin said.

Erin is right; there are regularly scheduled orientations where people can go and ask social workers and other staff questions about the requirements and what it’s like to be a resource parent. No commitment is required at the initial orientation. You can find a list of upcoming orientations on the DCFAS website.

“There’s no rush. The County doesn’t pressure you to rush,” Erin said.

Once a potential resource parent completes an orientation, they can start the interview and application process at their own pace. You can read a full list of requirements for resource parents on the DCFAS website. Going through the process not only changed Britney and Erin’s lives but the lives of the dozens of youths they’ve helped over the years.

“I still looked at them as family, like, over the top. Like, they’ve done things for me that my family has not even done, and that’s, that’s why I stand by, you know, blood doesn’t make you family. It’s really about the things that people do and the stuff that, the actions and the care of love, you know, and the way they show love. So, I really appreciate Erin, and just Brittany and everyone who was involved in my life, cause that did impact me. I don’t know where I

would be. You know, I’d probably be somewhere else if I wasn’t placed in their house,” Jalen said.

The words from Jalen are emotional for the two moms. Erin said those words are also an important reminder about why they chose to help kids and teens in need – even when those children were struggling sometimes with grief, the loss of their home, anger and anxiety.

“We’ll figure it out. We’ll get through it together. We’re going to find a way to make this work, you know? And we’re still supporting those kids in the transition from our home to wherever it is their next place may be.”

Currently, there are 539 families approved to foster in Sacramento County. More than 300 of those families are relatives or non-related family members (NREFM). A NREFM placement can refer to a person known in a foster youth’s life, like a pastor, coach or tribe member, that the child already has a relationship with. Being placed with family or an NREFM can sometimes ease the transition into foster care because the child is not placed with a stranger. However, not every family has people they can rely on during difficult times that lead to youth ending up in foster care, and applications are always open for people to become resource parents.

“We could not do this without our resource parents, the families who are willing to step in for the children in their lives, and our non-related family members, and all our community partners,” Child Protective Services Deputy Director, Melissa Lloyd said. “It is a privilege to know so many people who help our foster youth during what is often one of the most difficult times in their lives. Over the more than 25 years I’ve worked with Child Protective Services, I’ve seen so many people rally around these kids and lift them up – but there is always a need for more support. This commitment and the day-to-day responsibility of caring for foster kids are not always easy – but we must realize that it is often much more difficult for the youth who are placed into our care.”

If you are interested in helping a foster youth but

are not in a situation to become a resource parent, you can still support the youth in different ways.

Since the 1980’s, Sacramento County employees have gathered donated gifts for foster youth and older adults in need. The gifts and any financial donation go directly to foster youth or adults who are Adult Protective Services Clients. Recently, the program leaders realized there was a year-round need for basic items and birthday presents. Reach out to GFTH@saccounty.gov to find out how you can make a difference.

The Sacramento LGBT Community Center is a community partner that helps all LGBT youth with a welcoming space. More than one-third of Foster Youth identify as LGBTQ+. You can find out about how to donate or volunteer by visiting the Sacramento LGBT Community Center website.

The Sacramento CASA Program is a volunteer-based program that supports foster youth. You can become a CASA (Court Appointed Special Advocate). As a CASA, you advocate for the needs of the child you are matched with.

A CASA gets to know a child’s situation, communicates with professionals on the case, and makes sure the child’s needs are being met. CASAs also get to enjoy fun activities with the child they are assigned – many take them out for activities like bowling or going to the park so the child can find joy during a stressful time in their lives.

Home isn’t always the place where you’re born or the address on your driver’s license. Sometimes, it’s the people who choose you, stand by you and remind you that you matter.

For Jalen, Lottie, Leilani and so many others, Britney and Erin didn’t just provide a place to sleep; they gave them something every child deserves: a home and a sense of belonging. Britney and Erin’s story is a reminder of what is possible when a community chooses to show up for its children and teens.

Every child deserves a place to belong, and together, Sacramento County can help make that possible. ★

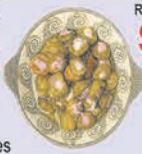

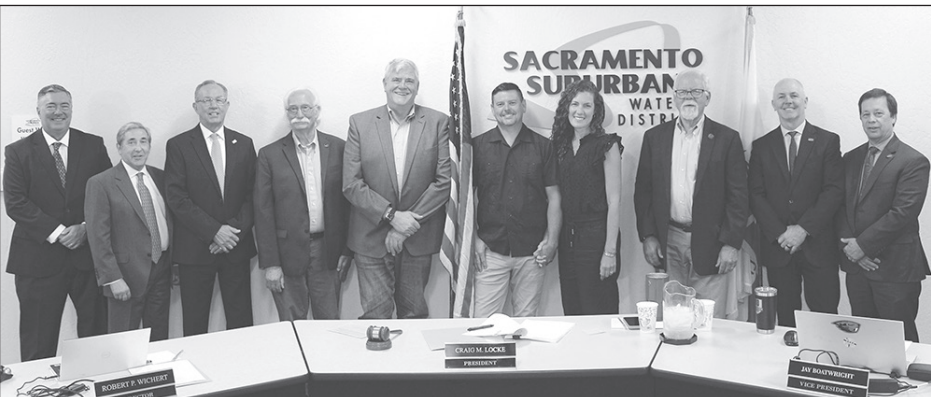

Sacramento Suburban Water District Purchases Groundwater Well Contractor to Secure Scarce Expertise

SACRAMENTO, CA (MPG) - Sacramento Suburban Water District (SSWD) announced it has purchased Kirby’s Pump and Mechanical (KPM), a California Class A General Contractor that specializes in mechanical work on groundwater well pump systems.

Licensed groundwater well contractors are in short supply in California. Adding KPM’s expertise allows the district to maintain pumping capacity and respond quickly to repairs, both reactively and proactively.

SSWD entered into an exclusive agreement with KPM in 2023 to maintain and repair the district’s 70-plus groundwater wells for the next five years. SSWD relies on groundwater, and having exclusive

access to their services was critical to avoiding prolonged well outages.

“During the three years that KPM worked exclusively with SSWD, they’ve made a significant difference in strengthening the reliability of our water system,” said SSWD General Manager, Dan York. “Their work has restored approximately 100,000 GPM of pumping capacity. They have also rehabilitated 19 wells, upgraded and repaired motor and electrical service and made numerous other improvements that made our operations more efficient.”

SSWD staff evaluated KPM’s performance over the initial years of the contract. It was determined that KPM could not only undertake standard well maintenance and rehabilitation but also perform a wide range of additional tasks.

They also found that

SSWD has the facilities to house KPM staff and equipment.

A Board of Directors committee reviewed KPM’s performance and commissioned an independent cost-benefit analysis. The independent analysis found that SSWD would recoup the KPM purchase in under 3.5 years and achieve approximately \$7 million in cost savings over a ten-year period compared with maintaining the current contract.

“Today’s purchase of KPM marks another important moment in SSWD’s commitment to water reliability and infrastructure improvement,” said President, SSWD Board of Directors, Craig Locke. “It’s a fiscally responsible decision that strengthens our water system for our ratepayers and the community at large.”

Stop with the negative about what you don’t like about Zach Lavine and Domantas Sabonis and start celebrating what they bring to the table.

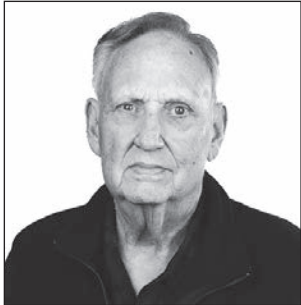

Tech Devices in California’s New Cars Create Thorny Political Issues

Automobiles have gradually evolved over the last two decades from mechanical devices into electronic platforms featuring computer screens and numerous other digital capabilities.

A few years ago, the California Air Resources Board began requiring automakers to install devices in vehicles to record and store operational data that the agency could access to determine how well emission reduction programs were working.

It was one aspect of the state’s announced goal of phasing out cars and trucks powered by gasoline and diesel fuel and replacing them with zero-emission vehicles.

The auto industry opposed the data collection mandate, arguing it would violate the privacy of vehicle owners. At one point the industry threatened to stop producing cars for California.

The agency insisted it would not collect data involuntarily. But its regulation fueled — pun intended — suspicions in some quarters that recording how and where cars were being used would allow them to be tracked, much as cellphone usage can be traced.

Or, some said, as gas and diesel use declined and gallonage taxes dropped, the state could begin charging drivers by miles driven, based on their recorded data.

As the data collection mandate was being implemented, another aspect of the situation surfaced — fears that the tracking software to help motorists obtain help in emergencies, such as General Motors’ OnStar system, could be misused by abusive spouses to find and attack their mates.

Two years ago, the Legislature and Gov. Gavin Newsom enacted a law aimed at countering that potential abuse. Senate Bill 1394 required automakers to provide an internet process by which a “connected vehicle service” could be quickly terminated. Those seeking termination would have to prove they either owned the vehicle or possessed it via a divorce decree or domestic violence restraining order.

That was the relatively easy part of SB 1384.

The more contentious portion of the law required new cars to be equipped with a “mechanism that can be used by a driver who is inside a vehicle to immediately disable connected vehicle location access.” The mechanism had to be “prominently located, easy to use, not require access to an online application, not require a password or login information, and only allow re-enabling of the connected vehicle location access by a driver who is located inside the vehicle.”

The deadline for meeting that requirement was last week. The industry has insisted that was, from a practical standpoint, impossible to meet because it is a complex engineering problem that involves dozens of different auto models, and automakers would have to maintain existing electronic tools, such as GPS navigation, and helpful services, such as OnStar.

Without a change in the mandate, the industry’s lobbyists warned, automakers could be compelled to suspend sales in the state, echoing a threat they made about the Air Resources Board’s data collection mandate earlier.

It was something of a political standoff until Senate Bill 719 emerged from backroom negotiations late last month. Just one day before the deadline, Newsom signed the bill that narrows the application of the requirement, eliminates the hard deadline for it and substitutes a series of deadlines tied to model years and “technological feasibility.”

Thus it is impossible to say for certain when, if ever, cars will be equipped with the ability to disconnect location tracking software.

These two instances imply that the conversion of the automobile from a mechanical device to an electronic one has created a bottomless well of potential issues involving privacy, governmental regulation and the politically heated topic of how California would change the way motorists are taxed once the gallonage taxes on fuels disappear, if they ever do.

Social Security Matters

When Should My Wife File for Spouse Benefits?

Dear Rusty: My wife is 66 (born February 1960) and started taking Social Security retirement benefits just over one year ago at age 65. She was a stay-at-home Mom for most of her adult life. I turned 62 this past March and received my first SS payment recently for a May 2026 start. We are scheduled to meet with SSA in late July to initiate spousal benefits because my wife’s current benefits are less than 50% of mine. We also have an adult disabled son who receives Supplemental Security Income (SSI) and Social Security benefits (this split in benefit sources happened after my wife filed - that whole process was confusing and we don’t understand it). My question relates to spousal benefits (I was a career finance person but don’t completely understand these rules). We were going to file in July but is there any benefit to waiting until she turns 67? And will her 50% benefit be 50% of my lower benefit due to my filing at 62 or is that based on another amount? Signed: **Confused Finance Guy**

Dear Confused: First, be aware that your wife’s spousal benefit will be based on her age when she claims it, and half of your full retirement

age, or “FRA,” amount (although you claimed at 62, her benefit as your spouse will still be based on your FRA entitlement).

Because she claimed her SS retirement at 65, your wife will not get 50% of your FRA entitlement; rather she will get her own reduced SS retirement benefit (which was reduced by about 13% from her FRA entitlement) plus a “spousal boost.” The amount of that “boost” will be the difference between her own FRA entitlement and half of your FRA entitlement, but that boost amount will also be reduced because she will be claiming in July before her FRA.

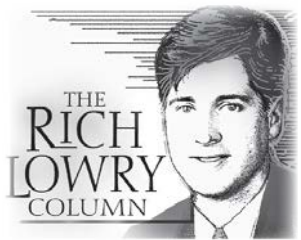
Your wife will reach her FRA in February 2027, so by claiming her spousal boost in July her boost amount will be reduced by about 5%, and the “boost” will be added to her already reduced SS retirement about. The result will be your wife’s benefit as your spouse will be less than 50% of your FRA entitlement. And, FYI, your wife will be automatically deemed to be filing for her spousal benefit (she will not be able to defer claiming it).

As your son is now collecting SS benefits based on your wife’s personal SS record, you should ask Social Security to switch him over to payments based on your record (because you have the higher SS benefit). FYI, because your son is now receiving SSI (Supplemental Security Income), the SSDI (SS disability) benefit he receives will offset by his SSI benefit, and the payment amount will consist of two sources - SSI and SSDI. Nevertheless,

he cannot get more than 50% of your SS retirement amount and will likely be affected by the Family Maximum which may further reduce his SSDI entitlement.

Your wife’s benefit as your spouse will also be affected by the “Family Maximum,” which limits how much can be paid on any one person’s SS record (on your SS record). That also means that your wife will not get a full 50% of your FRA entitlement; rather she will get less because the family maximum limits how much all your dependents can receive to somewhere between 50% and 88% of your FRA benefit amount (after subtracting your own SS entitlement). That also means that your son’s SS payment, as well as your wife’s SS payment as your spouse, will be reduced to less than 50% of your FRA entitlement. SSA will be able to guide you through the Family Maximum calculations for both your son and your wife when you meet.

To recap all of this: a) your wife will be automatically deemed to be filing for her spousal benefit; she cannot delay until her FRA. b) her amount as your spouse will be less than 50% of your SS FRA entitlement. And c) both your wife’s and your son’s SS benefit will likely be also affected by the Family Maximum and, thus, be less than half of your FRA entitlement. Nevertheless, it was likely the right decision to claim as you have, considering that your son and wife have been receiving SS benefits for some time now, and both will continue to receive more as your dependents. ★



The preposterous case against the new defense bill

to coordinate between the U.S. and Israel on “bilateral defense technology research, development, testing, evaluation, integration and industrial cooperation.” The Pentagon will come up with a plan for such cooperation and report back to Congress.

That’s it. There is nothing about merging the general staffs of the U.S. military and the IDF; nothing about creating a joint office where Defense Secretary Pete Hegseth and his Israeli counterpart, Israel Katz, work together; nothing about giving Bibi Netanyahu partial control of CENTCOM.

That the United States would want a close working relationship with Israel on military technology is hardly surprising. Israel is one of the world’s most innovative societies and, given its precarious security environment, has become a leader in advanced defense technologies.

That a nefarious interpretation of the bill has gotten some traction underlines how any preposterous lie, so long as it’s about Israel, gets a hearing these days. Like many conspiracy theories, this one depends on a dark view of American society. We are allegedly so corrupt that we are handing control of our military to a foreign country without any senior military leaders or officials in an “America First” administration lodging a complaint. No wonder Tucker Carlson wants the kind of tribunals that attended the end of World War II.

At the first Nuremberg Trials, Wilhelm Keitel was found guilty of crimes against humanity

and hanged; at the second Nuremberg Trials, Mike Johnson will be found guilty of supporting mutually beneficial technology sharing between allies -- means of execution yet to be determined.

One pervarsity here is that Netanyahu conceives of the technological cooperation as a substitute for the U.S. military aid that he supports phasing out. In other words, enemies of Israel oppose U.S. military aid, and when a constructive plan is offered for how to go about ending it, they oppose that, too, as an Israeli plot.

Another pervarsity is that the U.S. should want a very close relationship with Israel on missile defense, an area where Israel excels and that, as we’ve seen in the Ukraine and Iran wars, is crucial to modern warfare. And yet, the same people who portray themselves as zealously protective of the U.S. national interest want us to turn our back on a source of technological advance.

Israel naturally fits in the Western alliance, but nations ultimately pursue their selfish interests. If we spurn the Jewish state out of irrational animus, it will inevitably look elsewhere and perhaps build a stronger relationship with China. Then we will surely be told by the critics now obsessed with ending the U.S.-Israel relationship that Israel has shown its true colors and deserves even more of our scorn.

Unsecured Property Tax Due Aug. 31

Sacramento County News Release

SACRAMENTO, CA (MPG) - Annual bills for Sacramento County unsecured personal property taxes for fiscal year 2026-27 were mailed on July 17 and are payable without delinquent penalties through Aug. 31.

Unsecured property tax bills are mailed to all owners of unsecured property in July of each year. If you owned unsecured property in Sacramento County, such as a boat or aircraft, or if you leased or owned fixtures and equipment related to a business on Jan. 1 and do not receive a tax bill by Aug. 8, contact

the Sacramento County Tax Collector's Unsecured Property Tax Unit at 916-874-7833, between the hours of 9 a.m. and 4 p.m., Monday through Friday, excluding holidays.

Nonreceipt of a tax bill does not excuse delinquency or allow the tax collector to cancel penalties or collection costs.

Tax bills become delinquent if not paid in the Tax Collector's Office by 5 p.m. on Aug. 31, or received by mail bearing a postmark of Aug. 31.

If the tax bill is not paid by the delinquency date, a 10% penalty and collection cost will be added. DMV registration may be withheld on watercraft if unsecured

property taxes are reported delinquent. If a tax bill remains unpaid after Oct. 31, collection costs and monthly penalties of 1.5% will be added to the base tax.

Payments may be made by mail or in person at the County Tax Collector's Office, 700 H St., Room 1710, between 8 a.m. and 5 p.m., Monday through Friday, holidays excluded. For credit/debit or eCheck payments, visit county-taxes.net/sacramento/property-tax.

Recognizing When a Situation Needs a Closer Look

Most residents who keep backyard poultry have a small flock and provide excellent care for their animals.

However, Animal Control officers occasionally respond to properties with unusually large numbers of roosters. Large concentrations of roosters can present animal welfare concerns, including

injuries caused by fighting among birds, inadequate housing, sanitation issues and limited access to food and water. In some situations, these conditions may also warrant further investigation into possible illegal activity.

Fighting Animal Cruelty

Cockfighting remains illegal throughout California and is considered a form of animal cruelty.

Animal Control officers

work closely with law enforcement partners when investigating suspected cockfighting cases. While no single observation confirms illegal activity, officers are trained to recognize patterns that may indicate birds are being bred, housed or conditioned for fighting.

These investigations help protect animals from abuse while supporting safer neighborhoods.

Supporting Responsible Rooster

Ownership

The updated ordinance establishes numerical limits for the incidental, non-commercial keeping of roosters based on parcel size while creating a registration process for qualifying properties that may need additional birds for recognized purposes.

It also establishes animal care standards, prohibits tethering and strengthens enforcement tools available to County staff. For many responsible poultry owners, the ordinance

simply provides clearer expectations for keeping healthy birds while being considerate of neighbors.

Protecting Animals Through Education

Animal Control officers do much more than respond to stray dogs and lost pets.

Each day they investigate reports of animal neglect and cruelty, educate pet and livestock owners, enforce local animal ordinances and work alongside law enforcement

to protect both animals and the public.

The new Crowing Fowl Ordinance helps officers address concerns before they become larger animal welfare issues while continuing to support responsible animal ownership throughout Sacramento County.

Second Straight Year of Vehicle Theft Declines

SACRAMENTO, CA (MPG) - July is National Vehicle Theft Prevention Month, and the California Highway Patrol (CHP) is reminding Californians to protect their vehicles while highlighting encouraging statewide trends. California recorded its second consecutive year of declining vehicle thefts in 2025, as the CHP continued working with local law enforcement agencies to combat organized vehicle theft through targeted enforcement and public awareness.

According to the CHP’s 2025

Vehicle Theft Fact Sheet, thieves stole more than 133,000 vehicles statewide in 2025—about 25% fewer than the 176,230 stolen in 2024.

“Vehicle theft is not a victimless crime. It fuels organized criminal activity and creates hardship for families across California. The CHP remains committed to holding offenders accountable, recovering stolen vehicles and working with our law enforcement partners to make our communities safer,” Commissioner Sean Duryee said.

On average, a vehicle was stolen in California about every four minutes in 2025.

Of the 133,372 vehicles stolen statewide last year, 84% were recovered, for a total of 111,661 vehicles. More than half of the recovered vehicles were returned to their owners in drivable condition.

The decline continues a positive trend that began in 2024, when California recorded its first year-over-year decrease in vehicle thefts since 2019. That year, Governor Gavin Newsom deployed CHP officers to work alongside local law enforcement agencies in regional crime suppression operations. Targeted enforcement in Bakersfield, San Bernardino and Oakland helped contribute to reductions

in vehicle thefts and other crime in those communities.

Building on those results, Governor Newsom expanded CHP crime-suppression operations in August 2025 by deploying additional teams to high-crime areas across California.

Several counties where CHP crime suppression teams were deployed also experienced significant declines in vehicle thefts last year. Sacramento county experienced 5,061 vehicle thefts, down 23% from 2024.

Although vehicle thefts continue to decline, motorists remain the first line of defense. The CHP encourages

Californians to reduce their risk by following a few simple safety tips. CHP advises Californians to park in well-lit areas and remove valuables or keep them out of sight. Lock your vehicle every time you leave it, use an alarm system or other anti-theft device. Never leave your vehicle unattended with the engine running and report suspicious activity to law enforcement.

Through strategic enforcement, strong partnerships and public awareness, the CHP remains committed to reducing vehicle theft, disrupting organized criminal networks and keeping California’s communities safe. ★

Water Forum Awarded Funding for Lower American River Habitat Enhancement

Federal grants will improve habitat while expanding the science that informs future river management

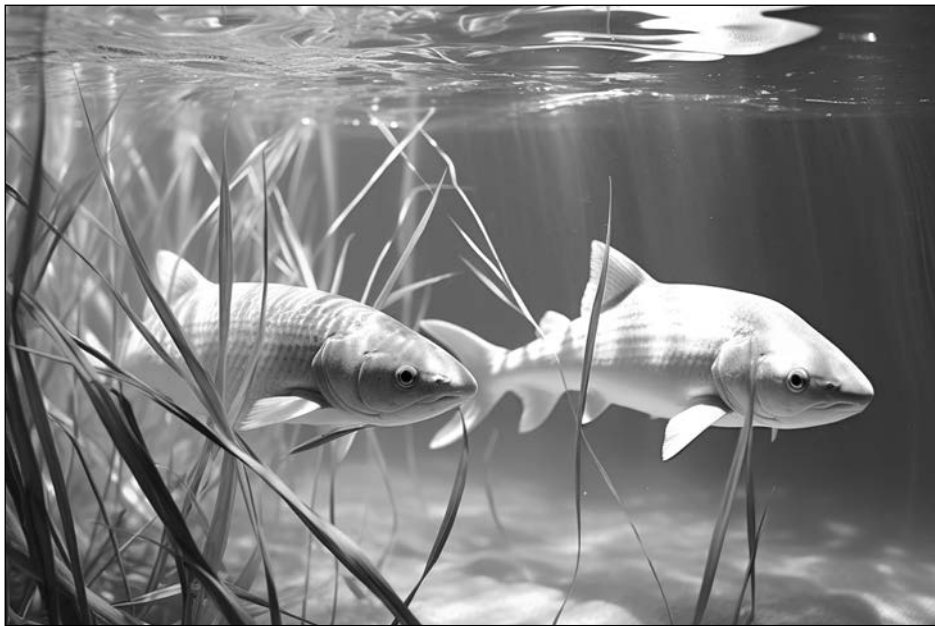

SACRAMENTO, CA (MPG) - The Water Forum has been awarded more than \$10.6 million in competitive federal funding to enhance habitat for salmon and steelhead in the lower American River while expanding the scientific research and monitoring that help inform future river management decisions.

“The lower American River is one of our region’s greatest natural resources,” Executive Director of the Water Forum, Ashlee Casey said. “This funding allows us to continue enhancing habitat for salmon and steelhead while using science to better understand what these fish need to survive and thrive. That knowledge helps us make better decisions that benefit the river, the fish that depend on it and the communities that rely on the river.”

The largest award—\$10 million—will support the long-term maintenance, monitoring and enhancement of habitat enhancement sites that the Water Forum has implemented along the lower American River over the past two decades.

“River habitat isn’t static,” Water Forum Habitat and Science Program Manager, Erica Bishop said. “High flows, shifting gravel, vegetation growth and other natural processes continually reshape the lower American River. What makes the Water Forum’s program unique is that we continue monitoring these sites over time and

use what we learn to make targeted habitat enhancements that provide the greatest benefit for salmon and steelhead.”

The project will also monitor how salmon and steelhead use enhanced habitat. It will also map the river corridor using advanced sonar and LiDAR technology to identify future habitat enhancement opportunities. And conduct scientific studies to better understand how habitat enhancement influences fish survival and reproduction.

The second award—\$627,835—will fund a major new study of Central Valley steelhead in the lower American River.

“Steelhead are much more difficult to study than salmon because their behavior and life cycles vary considerably and they are fewer in number,” Bishop said. “This study will help answer important questions about how steelhead grow, move through the river, survive and return to spawn.”

The findings will help scientists and resource managers make more informed decisions to protect this species that is listed as threatened under the Endangered Species Acts. The study will complement similar research on the Stanislaus River, providing valuable comparisons between steelhead populations north and south of the Sacramento-San Joaquin Delta.

The awards build on more than two decades of collaboration under the Water Forum Agreement and support implementation of the Water Forum 2050 Agreement, which strengthens the region’s commitment to habitat enhancement, scientific monitoring and collaborative solutions that protect the lower American River while supporting long-term water supply reliability.

The awards, announced by the U.S. Bureau of Reclamation and the U.S. Fish and Wildlife Service, include two of only 10 projects selected statewide through the Central Valley Project Improvement Act. The Water Forum received one of just four habitat enhancement awards and one of six scientific research awards funded this year.

Funding is provided through the Central Valley Project Improvement Act. The steelhead study grant will be administered by the U.S. Fish and Wildlife Service, while the habitat enhancement grant will be administered by the U.S. Bureau of Reclamation. ★

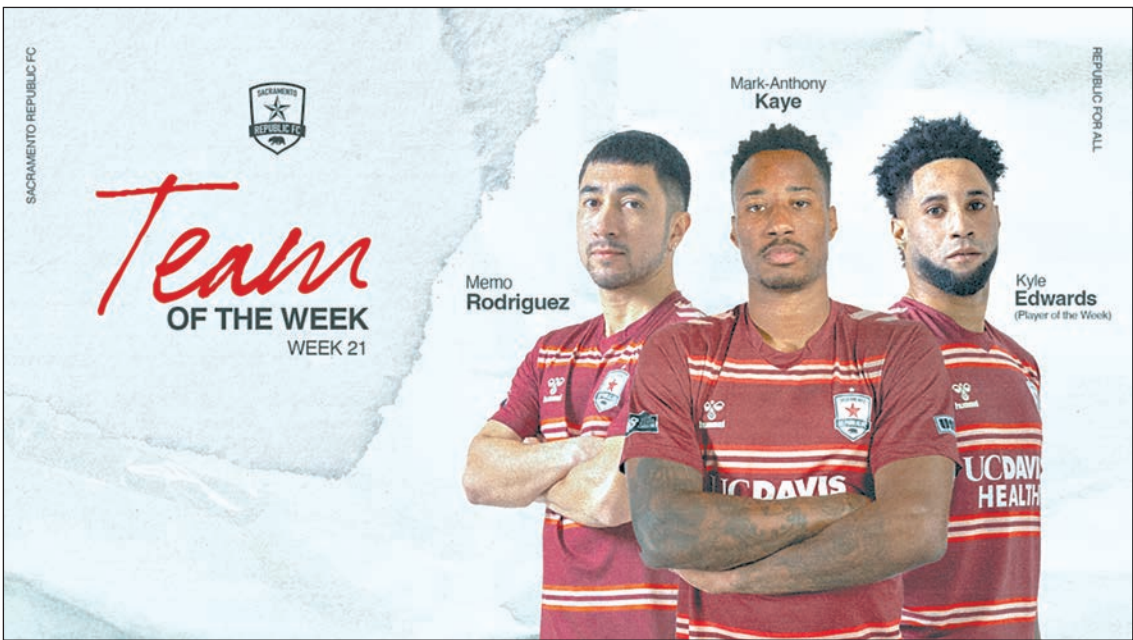

From then on, it was all Republic as the club put on an unrelenting press that kept the Roots under constant pressure. Mark-Anthony Kaye was a disruptor in the midfield all night with 9 of 10 duels won, six possessions won and three tackles won. The veteran midfielder has now been selected to back-to-back Team of the Week rosters.

The press paid dividends when Kyle Edwards took the lead for

good in the 75th minute, just six minutes after subbing on. A shot from Blake Willey forced the goalkeeper to make a save, but the rebound only went as far as a wide-open Edwards, who got the jump and volleyed a shot to the back of the net.

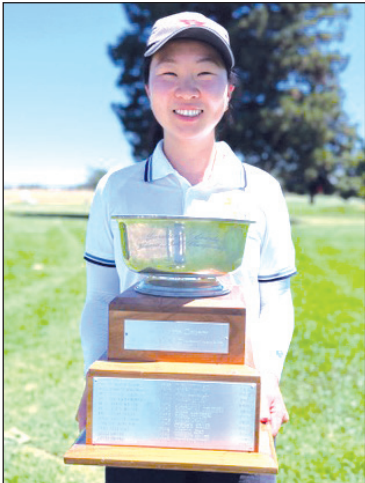
Katherine Zhu emerged as the 2026 Sacramento County Women’s Champion, capturing the Championship Flight title with
