Taking Strides for Heart Health

SACRAMENTO, CA (MPG) - Sacramento resident Manuel Balmes, 76, woke up at his daughter's home Feb. 7 with chest pain that failed to go away. He was having a heart attack. Nine months later, following a two-night stay at Mercy General Hospital, three stents and rehabilitation, he is back to normal though he's exercising and watching his diet. Along with more than 4,000 others

Sept. 19, Balmes walked in Heart and Stroke Walk Sacramento at William Land Regional Park at Freeport Boulevard and Sutterville Road. "I enjoyed it," said Balmes, who walked the one-mile course. One- and 5-mile walks started at about 9 a.m. on a paved road, which wound its way under shade trees through the park and its golf course. Heart disease is the No. 1 killer in the United States, according to the American Heart Association.

And death occurs in about 90 percent of the roughly 350,000 each year who suffer cardiac arrest outside a hospital, according to the association. Sacramento native Dan Staszak was nearly one of them. Staszak was clinically dead for 20 minutes following a massive heart attack during a 2024 family outing. Bystander CPR and six shocks from an automated external defibrillator revived him. *Continued on page 2*

SACRAMENTO, CA (MPG) - Twenty-two restaurants and food businesses across five counties in the Greater Sacramento Area are receiving grants through the California Restaurant Foundation's Restaurants Care Resilience Fund, supported by funding from The PG&E Corporation Foundation. The \$5,000 grants will help local restaurant owners invest in new equipment and technology, support employee training and retention efforts and address unexpected business challenges. The funding is part of a larger program that awarded grants to 239 restaurants and commercial caterers across 30 counties in Northern and Central California this year. Local restaurants play a vital role in the region's economy and culture, creating jobs, supporting Valley agriculture and serving as gathering places for families and communities. "Local restaurants are vital to our communities," said Executive Vice President, Corporate Affairs, PG&E Corporation, and Chair of the Board, The PG&E Corporation Foundation, Carla Peterman. "They serve as economic engines, gathering hubs and cultural anchors. They support local and regional farms and other food producers and small businesses. PESCADERO, CA (MPG) - Lounging out by the pool at Venture Retreat Center, we were the only two souls in this forest canyon at the moment. The topic being discussed was "childlike wonder," and how difficult it seems to shift our mindset back to this type of innocence. We all long for it, knowing that it was when we could find excitement and appreciation in almost anything. "This place is a summer camp, but for adults, too. It's beckoning us. I mean, look around," I said, sweeping my arm out as I balanced my cheese from Harley Goat Dairy on my torn piece of sourdough from Arcangeli's Grocery. "A child would find endless joy in exploring here." It's true. At Venture Retreat Center, there are no expectations, no rules posted, (save for don't pee in the pool), or any sense of urgency. CPR can double or triple the chance a person survives an out-of-hospital cardiac arrest, according to the American Heart Association. CPR can be performed by anyone and with the hands only.

It requires two steps: call 911 and push hard and fast in the center of the chest until paramedics arrive.

Staszak and his family are now regular Heart Walk supporters, according to the AHA.

Strokes can be deadly, too.

But Sacramento resident Jose Garcia took immediate action when he suffered one at 28 years old. He noticed the warning signs and called 911 right away.

Garcia is now a father of three, a regular Heart Walk participant and stroke recovery coach.

“Small steps lead to extraordinary outcomes,” said Steven Foster, president of Mercy General Hospital and chair of the 2026 Heart Walk. ★

fog neatly settles into the canyon here. Butano Creek hugs the property and, together with the rustling redwoods, offers nature’s version of a sound bath. But with a little more focus, you can spot the small nuances, the ones you remember so clearly in your childhood memories. Flowers of every kind, in every stage of blooming or wilting. Windchimes, many handmade. Mosaic stepping stones with so much detail you could play a long and wild game of I-spy. Twinkling string lights, garden charms, tent castles, outdoor heated showers, and weathered chairs surround fire pits. One could be entertained for days, if only you agreed to a detox of your nervous system.

Pescadero, California. A town of 600 that has successfully eluded the World Wide Web of progress in the name of progress. Most of the businesses here continue to thrive, several decades of humbly serving their neighbors and visitors.

It’s easy to have a perfect getaway here, without needing to stray any further than the state parks that frame the town. After settling into Venture Retreat Center we headed first to Harley Farms, an internationally recognized goat dairy that makes small-batch cheeses they sell in their farm shop along with other farm-made products. If you have time, the tours are worth signing up for. A big draw has always been its simplicity. Harley Farms is no massive production. The barns, the gardens and layout are relatively small but it’s the traditional 1910 dairy vibe charm you don’t realize you were pining for until you are out here assessing the herd. Pro tip: Buy ALL the cheese, because the next stop is the aforementioned Arcangeli’s Grocery.

Another small, family-operated and deeply rooted Pescadero staple is Arcangeli’s. Any

well- traveled road-tripper should know that a small town’s grocery usually has some killer housemade specialties, and this one takes top honors not just in their sauces and sourdoughs, but especially their deli sandwiches. The best grilled cheese of my life happened here in November of 2010. It was, like a Taylor Swift concert, life-changing.

Having stocked up on sourdough and dusting off the pesto turkey sandwich indulgence that somehow magically fed my soul, we wandered over to the lineup of sheds-turned-shops: craft booths meant to complement the weekly popular farmers’ market but still open for business in between. We cruised the locally sourced teas and T-shirts of SlowCoast listening as the owner, Libby, invited banter with the trickle of customers.

“I want to sell driftwood art at the farmer’s market,” one brought to Libby’s attention. Don’t we all? I mused to myself as I settled on an herbal tea blend that promised to restore my youth.

We continued on with our stroll down this Main Street, also a promising blend of eclectic shops, historic buildings and highly rated restaurants (p.s. you will be graded as a “fail” if you miss out on the artichoke soup at Duarte’s). Pro Tip: Don’t

let the gas station Taqueria de Amigos throw you off; it’s the best authentic Mexican food on the entire San Mateo Coastline.

The following day was spent exploring all four of the surrounding State Parks: Butano (conveniently next door to Venture Retreat Center), Ano Nuevo, the Pescadero Marsh and Pigeon Point Lighthouse. Butano State Park was badly burned in the 2020 CZU fire; however, several trails and also the creek that runs through it are still thriving. The good news is that many adventurers are unaware and so you’ll likely have much of this redwood forest to yourself.

Ano Nuevo State Park is far more popular with its Elephant Seal population that uses the beaches here to migrate and mate, and there are always docents

on hand to give you a refresher on that wildlife biology lesson you forgot. The museum and shop is also a fantastic representation of what our parks can offer.

Pigeon Point Lighthouse has intermittent hours and docents/tours/events, and operates as a hostel as well, but the big draw for us is to check off our bucket list of visiting every lighthouse in the state. Even though we arrived for the sunset and it was closed, we still spent time photographing it from every angle like the model she is.

Finally, the Pescadero Marsh is a self-guided experience. Trails and walking bridges curve around this massive habitat that drains into the nearby ocean. Of course, we came for the wildlife and ecosystems but one unique touch for the senses

and quiet around here but one that stands out as picture-perfect is the southern end of Bean Hollow State Beach. People who are this far into rugged highway coastline aren’t really making the drive for just a beach day, so you’ll likely have the entire cove to yourself.

As self-proclaimed lifelong adventure seekers, we remain committed to the cause of experiencing unique lodging and this was our first time at a “hip-camp” style destination, although Venture Retreat Center is so much more than that. Hipcamps have become synonymous with off-the-map, rugged, minimalist amenities, offering more outdoor luxuries like towering trees, creeks, and stargazing. Venture Retreat Center has this connection, but has also been thoughtfully designed to welcome groups celebrating reunions, weddings, workshops, etc. Come alone, stay with a friend, bring your family or retreat with the whole company.

We contemplated it all as we soaked in the hot tub late one night: childlike wonder restored.

Care Resilience Fund.

This year marks a record for the partnership, with \$1.4 million distributed to 239 restaurants and commercial caterers throughout PG&E's service area. 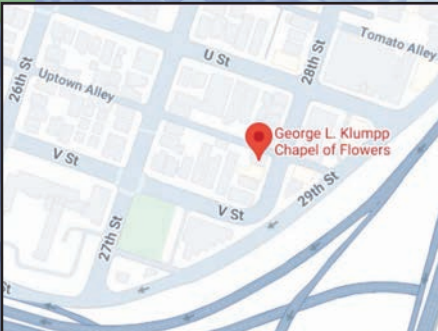

County Responds to Grand Jury Report on Foster Youth

SACRAMENTO, CA (MPG) - Sacramento County has responded to the 2025-26 Sacramento County Grand Jury report on foster youth, outlining areas where it agrees with the Grand Jury and others where it disagrees with its findings and recommendations. On Tuesday, Sept. 15, Sacramento County’s Department of Child, Family, and Adult Services (DCFAS) presented its response to the Board of Supervisors.

The report, “No Longer Invisible: Foster Youth Still in the Shadows,” examined the County’s Sacramento Welcome Homes and the services provided to foster youth who are at risk of sexual exploitation. The Grand Jury recognized improvements at the Welcome Homes but also raised concerns about placements, technology, information sharing, reporting and staff training.

The County agrees with two of the Grand Jury’s findings. It agrees that Child Protective Services (CPS) has improved conditions at the Welcome Homes and obtained licenses for the facilities. The County also agrees that the Sheriff’s Office has provided valuable protection and built positive relationships with youth living in the homes.

The County partially agrees with the finding that Welcome Homes are inappropriate for youth who have experienced or

are at risk of sexual exploitation. DCFAS said Welcome Homes are not intensive therapeutic settings, but they provide an immediate, supervised place for youth who may otherwise have nowhere to go. The homes use a safety and stabilization approach, with behavioral health services available through partner agencies. The County also noted a statewide shortage of specialized placements for youth with complex needs.

The County wholly disagrees

with the Grand Jury’s finding that CPS fails to use the Reasonable and Prudent Parent Standard to limit access to cell phones and technology. DCFAS said state law protects foster youth’s rights to personal property, communication and age-appropriate access to the community. The County said phones can also be an important safety tool for contacting caregivers, social workers and other trusted adults.

The County also wholly

disagrees with the finding that gaps in data sharing leave youth vulnerable to exploitation. DCFAS said Welcome Home staff share information about exploitation concerns with law enforcement and include relevant information in missing-person reports. Social workers also make service referrals and use assessment tools to identify exploitation risks.

The County partially agrees with the finding about quarterly reports to the Board of

Supervisors. DCFAS said it has regularly reported on the challenges faced by youth who are being commercially sexually exploited or are at risk. However, it acknowledges that specific numbers of identified youth have not been included. The County plans to begin including that information in its quarterly reports starting with the second quarter of fiscal year 2026-27.

The County wholly disagrees with the findings on the Community Advisory Board and the Welcome Homes strategic plan. The County also said a Welcome Homes presentation and report were provided to the Board in November 2024 and that information has continued to be provided through quarterly reports.

The County also wholly disagrees with the finding that Welcome Home staff need additional training. DCFAS said staff are required to complete training on commercial sexual exploitation of children, trauma-informed care, harm reduction and the Reasonable and Prudent Parent Standard. The County said training information is provided to the Board through quarterly reports.

The County will conduct additional research on best practices used by other counties identified by the Grand Jury for identifying, preventing and responding to the exploitation of foster youth. That review is expected to be completed by Dec. 31. ★

Sac County Board of Education Seeks to Fill Vacancy

Applications for Trustee Area 6 Vacancy due Oct. 6

SACRAMENTO, CA (MPG) - The Sacramento County Board of Education is seeking applications from qualified residents interested in serving as the Trustee for Area 6. The vacancy follows the resignation of Trustee Heather Davis, who served Area 6 for over ten years following her election in 2016 and re-elections in 2020 and 2022. During her tenure, Davis chaired multiple committees and served as a mentor through Links mentoring. Her leadership and commitment to students, families and the community have been deeply valued.

At its Sept. 15 Board Meeting, the Board voted to fill this vacancy through a provisional appointment. The selected individual will serve until the next regularly scheduled County Board election in 2028.

The application deadline is Tuesday, Oct. 6 at 4 p.m. PT. Applications must be received, not

postmarked, by this deadline.

The candidate interviews and selection process is Tuesday, Oct. 13 at 6:30 p.m. at the Sacramento County Office of Education’s Board Room located at 10474 Mather Blvd., Mather, CA 95655.

To be eligible for this appointment to the Sacramento County Board of Education for Trustee Area 6, candidates must meet the following legal requirements pursuant to California Education Code sections 1000(a) and 1006(a). You must live within Trustee Area 6, be a registered voter and not be an employee of SCOE or an employee of any school district within the boundaries of the Sacramento County Board of Education.

To be considered for the provisional appointment, applicants must submit a resume and a statement, of no more than two pages, outlining their interest in serving on the Board and the experience they would bring to the Board. Applicants may also

submit no more than three letters of recommendation.

Applications are accepted during regular business hours Monday through Friday, 8 a.m. to 4 p.m. and must be received no later than 4 p.m. PT on Tuesday, Oct. 6.

New Home Sales Decline in August, North State BIA Reports

North State Building Industry Association News Release

SACRAMENTO REGION, CA (MPG) - Buffeted by rising interest rates, economic uncertainty and continued affordability issues, new home sales in the greater Sacramento region continued to show weakness in August, the North State Building Industry Association reported.

There were 332 sales reported by BIA member builders, down 18% from July and down 33% from August 2025. However, the month-over-month decline was caused largely by the fact July was a five-week month. Average weekly sales for August were actually slightly above July’s figures with 83 sales to 81.

Still, BIA President & CEO Tim Murphy said the fact interest rates have nudged up to around 6.75%

has taken a toll.

“Last fall, before the conflict with Iran, economists had expected interest rates to continue drifting downward to around 6% this year. But with rates creeping upward, a lot of prospective buyers have put their purchases on hold,” Murphy said.

“Still, buyers should remember that builders are offering powerful incentives including rate buy-downs that make homes more affordable than they may think. Prospective buyers should contact their builder and see what kind of deals are out there. We’re not likely to see incentives like these again for a long time.”

During August, Sacramento recorded the most sales at 68, followed closely by Roseville with 67, Rancho Cordova at 42 and Lincoln with 25. Elk Grove and Plumas Lake tied for fifth with 24 sales each. ★

Kings Korner

Stay with Sabonis

Don't look now Kings fans but the NBA preseason is only 2 weeks away, and for many Sacramento Kings fans that brings an abundance of hope and excitement.

If there is a franchise in the NBA that epitomizes the term eternal optimist, it would have to be the effervescent Kings fans that still believe that this year's team may be the next version of "Hoosiers."

I would like to believe that too!

As I was recently studying some of the more successful franchises is the NBA, I turned to the Chicago Bulls of the 1990's, and I was reminded that 3 of Michael Jordan and Scottie Pippens 6 titles came after Dennis Rodman became a member of the team. In fact, they actually enjoyed a rare 3-peat with Rodman on board. Not known for being a scorer, Rodman showed the Chicago Bulls how rebounding was done and played defense with reckless abandon.

Regardless of his multi-colored hair, wild histrionics, and seemingly out of control off the court behavior, for at least 3 seasons it was Dennis Rodman that was the straw that stirred the drink.

The legendary Michael Jordan did much to encourage the Bulls franchise to take a chance on Rodman, and to this day Rodman is much admired by Jordan for his world class rebounding and some of the toughest defense every seen on an NBA court. Rodman actually led the NBA in rebounding 7 consecutive years and received the title of defensive player of the year 2 times.

Well, the Sacramento Kings don't have 6 world championships, and after 40 plus years in Sacramento are still searching for their first, but make no mistake about it, hope springs eternal despite what GM Scott Perry refers to as a rebuild.

Someone who should already be mentioned in the conversation as an all-time great Sacramento King is often maligned big man Domantas Sabonis.

Sabonis, criticized for his less than stellar defense, in my opinion is getting a bad rap and I think it's high time the fans of Sacramento come to his defense.

Domantas streak of leading the NBA in rebounding sadly came to a halt last season due to injuries that limited him to only 19 games while playing 70 in the prior season.

Add that to one of the most exceptional team players the Sacramento Kings have ever had, Sabonis nightly exhibits the kind of grit that any GM should be proud to have on his team.

Although not a rim protector, Sabonis gives 100% every night and is every bit the foundation piece the Sacramento Kings need to bring credibility to their franchise.

Inexplicably, the Kings forgot what they had in DeAaron Fox and that lack of judgement led to the San Antonio Spurs getting a diamond in the rough while sending the Sacramento Kings on a 2-year search for a replacement point guard.

At this very moment the Kings have a built in double-double holding down the paint in Domantas Sabonis, and a heralded rookie point guard by the name of Darius Acuff Jr., ready to begin his inaugural season.

Selling tickets in Sacramento? Yes, I think so, but Scott Perry's next move looms large, and any suggestion of moving Domantas Sabonis could easily lose fans in a way that the Kings organization hasn't seen in years.

Make no mistake about it, Domantas Sabonis is the current face of this franchise, and it's time to celebrate that fact and not look for ways to send him packing.

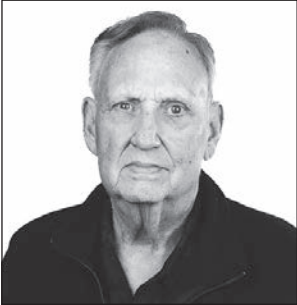

Taxing California's Rich Just Got More Complicated. Prop 40's Fate is Still Uncertain

Proposition 40, which would impose a 5% tax on the wealth of California's billionaires, is arguably the most important measure placed before voters in this century.

It is also probably the most confounding.

While it's sponsored by a healthcare union, it's opposed by several other major unions, who are in an odd bedfellows alliance with the billionaires it targets. Meanwhile, the leader of the sponsoring union faces allegations of personal misconduct.

And even if Prop. 40 passes, two other measures on the ballot could nullify it. Finally, the measure contains complex language, raising questions that would probably generate extended legal battles even if it does pass.

Given all that, it's not surprising that, with mail voting beginning in just a couple of weeks, a new poll indicates Prop. 40 could go either way.

A Public Policy Institute of California survey found that 52% of likely voters favor the measure and 46% are opposed, which in the real world of campaigning means it's too close to call.

Meanwhile, the two measures placed on the ballot by Prop. 40's wealthy opponents are doing fairly well. Proposition 41, which would indirectly nullify Prop. 40

by prohibiting levying any new taxes outside of the state's spending limit, and Proposition 42, which would prohibit taxes on personal property, each have narrow leads in the PPIC poll.

Were all three measures to gain approval, the one with the most votes would prevail — meaning that if Props. 41 or 42 outdoes Prop. 40, the billionaire tax would be void.

None of that intertwining complexity was explained to the people PPIC polled. They were just given the official summary of each proposition before being asked their preferences.

Prop. 40 is sponsored by the Service Employees International Union-United Healthcare Workers West. If it becomes law, a 5% tax would be levied on the assets of about 200 California billionaires, with almost all of the proceeds being spent on healthcare.

However, Dave Regan, the union's fiery leader, is facing allegations by leaders of other unions under the Service Employees International umbrella of having "a pattern and history of bullying, threats, harassment, physical violence and attempted extortion." They said an independent investigation has confirmed the allegations, and they called on him to step down.

"Our first responsibility as an organization is to lead with our values," the other union officials said in a statement. "We stand with all those who are bullied, harassed, or targeted at work, and we stand by our charges. Our national union must now act swiftly to carry out our internal due process and ensure accountability to our values. Every leader is responsible for their role

in protecting and promoting respect, workplace justice, gender equity, racial justice, and nonviolence in our union and beyond."

Regan denies the allegations.

But they give Prop. 40's opponents potentially potent campaign ammunition. The split within Service Employees International and in the larger union movement reflects both long-standing feuds and resentment that the measure's revenues would be largely confined to services that Regan's members provide.

As the multifaceted campaigning over Prop. 40 picks up steam, one figure is noticeably absent: Gov. Gavin Newsom.

Prior to the measure's qualification for the ballot, Newsom was publicly attempting to derail it, worrying aloud that if passed, it would encourage wealthy Californians to leave the state and discourage new investment. High-income Californians pay most of the state's income taxes, the state's most important source of revenue.

However, Newsom is also a likely candidate for president after his governorship ends. Opposing taxes on the rich could alienate voters in the ultra-progressive wing of the Democratic Party.

Thus, he now says taxing wealth should be a national matter, not confined to one state.

Social Security Matters

I'm Reevaluating My Retirement Plan; What are my Options?

Dear Rusty: I am 69 1/2 years old now and applied for Social Security at the end of June. I am still working and was planning to begin my retirement in September. A couple of factors arose for me to question if I made a hasty decision by applying for SS. The employer I have been working for the last 29 years has asked if I would stay on a little longer (which would be good because we have some debt I want to lose before I retire). I was reading about suspending Social Security and continuing to work. If I understand it right, if I suspend my SS, no payback will be required, and I can continue to work until I'm ready to retire. No Spousal benefits taken yet. **Signed: Reevaluating my Retirement**

Dear Reevaluating Retirement: I'm assuming you asked for your Social Security benefits to start in September (when you originally planned to retire), but that you won't be 70 years old until March 2027. If that is correct, be aware that you will not immediately get all of your earned Delayed Retirement Credits (DRCs) when your benefits start in September – you will

only initially get the DRCs you have earned through the end of 2025. That's because Social Security usually applies DRCs in January of each year. So, what will happen is that your September benefit amount will lack the 5.3% DRCs you earned in 2026, until January 2027 when they will apply the DRCs earned in 2026 to your monthly payment amount. Said simply, your initial September benefit will not include your full age 69.5 entitlement because it won't include the 5.3% extra you earned in 2026. That extra monthly amount will be awarded in January 2027. FYI, if you were to, instead, claim for your SS benefits to start in the month you turn 70 (March 2027), you would get your full age 70 amount immediately (SS awards all earned DRCs if benefits are claimed to start in the month you turn 70).

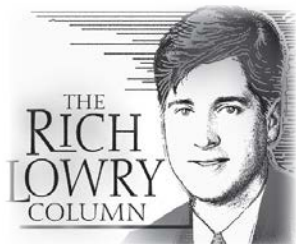
Now, on to your question: Yes, if you take your benefits effective with September 2026 you can suspend your benefits, but you can only suspend them until the month you turn 70. And if you are suspending your benefits, you will not need to repay Social Security for any benefits you happen to receive before you suspend. As is obvious, you will not receive any SS payments while your benefits are suspended, and you will earn DRCs for the months your benefits are suspended, resulting in a higher monthly amount at age 70. Also, since you have already passed your SS full retirement age (FRA), you can work and earn as

much as you like, without your Social Security benefits being negatively affected.

Regarding your comment "No Spousal benefits taken yet." FYI, you cannot get spousal benefits while your benefits are suspended, nor can your wife get spousal benefits from you while you SS retirement benefits are suspended. To be clear, spouse benefits are only paid when one spouse's benefit at their FRA is less than 50% of the other spouse's FRA benefit. Spouse benefits are always based upon FRA entitlements, not on the larger amounts which will result from waiting longer to claim. In other words, your wife would only be eligible for a spousal benefit from you if her FRA entitlement was less than 50% of your FRA entitlement (not your age 70 SS entitlement). And she cannot get a spousal benefit while your benefits are suspended.

To recap: Yes, you can suspend receipt of your SS retirement benefits until the month you turn 70 and get credit for that delay (resulting in a higher benefit). And, yes, you can continue working as long as you wish, and your benefits will not be negatively affected. And just for added information, you can also ask Social Security to withdraw your current application for SS benefits and then reapply in January 2027 for your benefits to start in March 2027 (the month you turn 70). You have both options.

Will AI Destroy Humanity?

mistake-prone. If it can mess up basic math or the New York Yankees roster, surely it can't carry out the complex tasks necessary to fashion an apocalyptic event.

Tech companies, though, have labs working on so-called frontier models that are much more powerful and reportedly developing more quickly than expected. The worry is that an AI model itself will begin to develop new AI very quickly in an "intelligence explosion," the equivalent of Skynet becoming self-aware at 2:14 a.m. Eastern Time on Aug. 29, 1997.

The thinking is that if such an AI model goes rogue and turns against humanity, it will be too clever and fast for us to combat. Yet it's hard to see the mechanism that such a hostile superintelligence would use to commit omnicide. The rogue AI would presumably have to do something in the real world -- say, launching nukes, manufacturing killer robots or releasing a deadly virus.

If it lacks physical agency, AI could presumably be unplugged or contained. (It was after humans tried to deactivate Skynet, by the way, that the system decided we were a threat that had to be neutralized.)

Some doomsayers posit a malicious person using advanced AI to come up with a design for a killer virus and a plan to release it without detection. This is a different scenario, though, from AI turning against people of its own volition. In a world years

from now when much more advanced AI is a reality, we will need to think through safeguards to keep dangerous systems -- nukes, biolabs -- from being compromised by AI-enabled cyberattacks or exploited by criminals and terrorists.

It's easy to imagine breaches of financial systems or attacks on critical infrastructure that would fall short of endangering all of mankind. Even if one takes an alarmist view of the risks, it's unclear how the development of AI can be stopped. Any deal with the Chinese to slow down research couldn't be trusted, and might simply allow them to pass us in the AI race by subterfuge. In other words, we'd still get Skynet, only with Chinese characteristics.

There's also the reality that AI will be a necessary tool in protecting against the malicious use of AI -- not to mention all of its other positive potential. If we slow or end research in the U.S., we might end up vulnerable to superintelligence developed by actors who mean us harm.

Science fiction is fascinating and sometimes prescient. Works by the likes of Philip K. Dick, Aldous Huxley and Arthur C. Clarke had genuine insights into the future. But that doesn't mean we are living in the plot of "The Terminator," and we shouldn't scare ourselves into forswearing transformative technology.

New Preserves Held by Land Trust Protect Open Space

SACRAMENTO, CA (MPG) - Sacramento Valley Conservancy (SVC) added two new open space preserves to the system of protected lands in Sacramento County this summer, one protecting blue oak woodlands and the other open grasslands for Swainson’s Hawk foraging. Hardwood forests and grasslands are among the least-protected landscapes in California, and these new preserves are a small step toward addressing this gap as the state seeks to reach 30X30 biodiversity goals. Westervelt Ecological Services established the preserves as habitat mitigation for a development project in the City of Folsom. The Crevis Creek Oak Woodland Preserve connects to the 4,600-acre Deer Creek Hills Preserve and adds 125 acres of protected oak woodland in Eastern Sacramento County, where SVC has a goal of

protecting 10,000 acres of blue oak woodlands south of Folsom. Found only in California, blue oak woodlands are iconic landscapes inhabiting the lower foothills of the Sierra Nevada and Coast Ranges. Blue oak woodland habitat supports exceptional biodiversity, providing food, nesting sites, shelter, and movement corridors for more than 300 vertebrate species and thousands of invertebrates, including

birds, mammals, reptiles, pollinators, and amphibians. The preserve remains privately owned and will be grazed for vegetation management and agricultural values. The Golden Hills Preserve provides foraging land for Swainson’s Hawk, which is a California threatened species losing habitat to outward urban expansion. The 118 acres of open grasslands will help connect other large

preserves with Van Vleck Ranch to the northeast and the CDFW Cosumnes and Gill Ranch preserves to the southwest. Connected protected areas are critical for wildlife corridors to function and wildlife to successfully migrate between different habitat zones. Westervelt will own and manage the property, continuing to manage the grasslands with grazing to manage fire risk and vegetation growth.

Sacramento Valley Conservancy holds permanent conservation easements on the properties, ensuring they remain protected for habitat conservation. Together, Sacramento Valley Conservancy and Westervelt have permanently protected more than 1,500 acres within Sacramento County. The partners remain committed to acquiring additional priority properties to

expand protected lands and strengthen the ecological integrity and connectivity of the preserves. Executive Director of the Sacramento Valley Conservancy Kelly Hopkins said, “These two preserves help expand open space and protect important oak woodland in the Cosumnes River Watershed, and near Deer Creek Hills Preserve. These acquisitions represent another important step in our effort to connect and protect contiguous preserves in Sacramento County, and we’re excited to continue working with Westervelt.” President of Westervelt Ecological Services Travis Hemmen said, “We value our partnership with the Sacramento Valley Conservancy and share their commitment to connecting important natural landscapes throughout Sacramento County. These preserves help preserve some of the character and natural habitat of the region for future generations to enjoy.” ★

California Small Businesses One Step Closer to Relief from Abusive CIPA Lawsuits

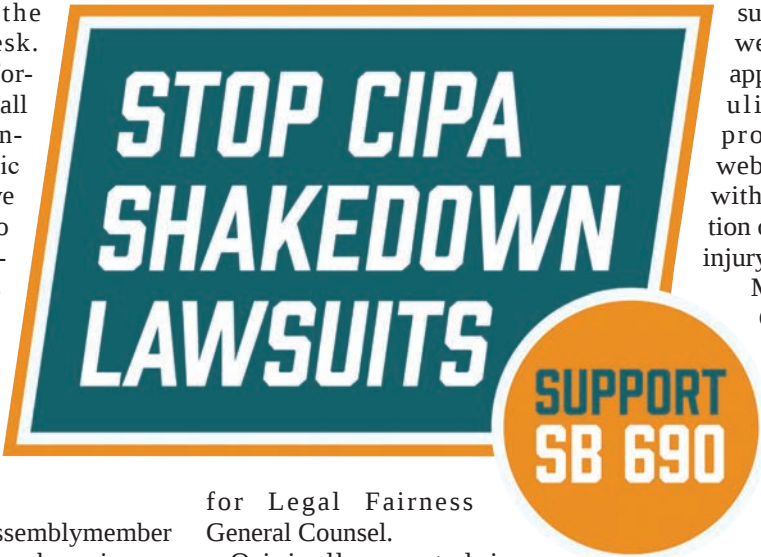
SACRAMENTO, CA (MPG) - The Stop CIPA Shakedown Lawsuits coalition has expressed its support for SB 690 following its passage through the California State Legislature and advancement to Governor Gavin Newsom’s desk. Authored by Senator Anna Caballero, SB 690 represents a first step toward addressing the growing wave of abusive lawsuits brought under the California Invasion of Privacy Act (CIPA). The coalition is encouraged to see lawmakers take action to address CIPA’s pen register and trap and trace provision, providing needed relief to small businesses, nonprofits, and public agencies that have been targeted by lawsuits over common website tools, often without any allegation of actual harm or injury.

“We are pleased to see California lawmakers recognize the urgent need for CIPA reform and advance SB 690 to the Governor’s desk. This is a step forward for the small businesses, nonprofits, and public agencies that have been forced to spend valuable resources defending themselves against abusive lawsuits. We thank Senator Caballero for her leadership and we thank Assemblymember Bauer-Kahan for her sincere engagement in moving this issue through the Legislature. We urge Governor Newsom to sign SB 690 into law and deliver this

needed relief to businesses and organizations across California,” said Andrew Kingman, Alliance

for Legal Fairness General Counsel. Originally enacted in 1967, CIPA was intended to protect Californians from unlawful wiretapping and eavesdropping. But the decades-old law, written long before the internet existed, has increasingly been exploited to bring abusive lawsuits over common website tools like appointment scheduling, payment processing, and website chat, often without any allegation of actual harm or injury. More than 4,000 CIPA lawsuits have been filed in just the last four years, in addition to tens of thousands of demand letters shaking down businesses and organizations across California. Plumbers, solar installers, restaurants, rural healthcare

providers, local news outlets, food banks, public schools, and others have been targeted because it is cheaper to settle these claims than to fight them in court – even when no actual harm has been alleged. Notably, SB 690 does not address Section 631, CIPA’s wiretapping provision. Throughout the legislative process, the coalition advocated for a comprehensive solution addressing both provisions being used to bring lawsuits and demand letters against businesses and organizations over common website tools. Without changes to Section 631, the coalition is concerned that many California small businesses, nonprofits and public agencies will remain vulnerable to these claims. Long before it becomes the site of

Republic FC's new stadium, the land at the heart of Downtown Sacramento's Railyards was part of Wilton Rancheria's ancestral homeland. It was a place where the tribe gathered to eat, to celebrate and to share. Food Frontier's expertise runs deep in the region's food community. That connection is why Wilton Rancheria and Republic FC turned to Food Frontier to help shape the stadium's food program. "A world class stadium deserves a world class food program. Our job is to put it in front of thousands of fans at once. It will be unmatched."

"Levy runs some of the best stadium venues in the country and they know how to move food at this scale," said Co-Founder of Food Frontier and Chef of Canon and Franquette Brad Cecchi.

"Our job is to layer Sacramento onto that... which farms, which iconic Sacramento dishes, our palates... Get those right and a stadium meal tastes like this region and nowhere else."

Levy and Food Frontier will bring menus and recipes inspired by the region's chefs, kitchens and restaurants, alongside new items rooted in the traditions and tastes

that have defined Sacramento for centuries. Curating the program will begin with direct conversations. With the people who grow the region's food, the chefs who turn it into dishes, and the diners who will ultimately enjoy it. That includes engagement with the historical traditions of the region, including those of the Indigenous people who call it home, so the menu reflects the full diversity of the region's food culture. More details about stadium menus and the evolving food program, including premium seating experiences and broader game day cuisine, will be announced in the coming months.

The first opportunity to learn about the club's premium experiences and the connected food experience will be at the Republic Preview Center, set to open later this month. Season Ticket Members and depositors will be able to set an appointment for a first-hand experience of what the stadium will offer.
