

Steamboat Springs Wedding Guide Cover Image Application

Guidelines

- Open to all wedding photographers 18 years or older.
- Artists may enter up to 3 pieces. **High-resolution Images** (300 dpi or greater) must be either burned to a CD, or uploaded via an alternative electronic medium (email, dropbox, you send it, etc...) and submitted with the attached application.
- Work must be photographers original composition.
- Entries are reviewed on the basis of originality, photographer conception, quality of workmanship and suitability for use as the cover art for a wedding guide publication.
- Ski Town Media, Inc. reserve the right to final publicity decisions.
- A high-resolution digital image of the winning photograph is required for use as the cover of the Steamboat Springs Wedding Guide. Preference will be given to those images featuring a clear shot of a bride, with a recognizable local setting as a backdrop.
- The winning artist will need to acknowledge and accept that it may be necessary to select a suitable detail from the winning photograph to fit the cover format of the Guide. The final cropping of the image will be at the sole discretion of Ski Town Media, Inc.
- By entering this contest, the photographer declares that the submitted art is his/her original work and that he/she has the legal right to publish it.
- Photographer holds the responsibility of the establishing the permission of the bride and groom to use their photographs in the Steamboat Springs Wedding Guide.

Entry Procedure

- **Photographs must be submitted by 5:00 p.m. (MT) on Monday, Oct. 24, 2016**
- Photographs will be juried from high res digital images.
- A completed entry form listing names of the bride and groom, location and year produced must be submitted with a CD of the images. Please remember that the quality of your images can greatly influence the jury's decision.
- Please submit an photographer's biography along with the above.
- No materials will be returned. Should your work be eligible for other promotional opportunities, you will be contacted for your permission to use your work. If a bride/groom or other owner should also be credited, it is your responsibility to inform the requesting party that there should be an additional credit.
- Winners will receive photo credit for the cover, plus an "About the Photographer" article in the 2017 Steamboat Springs Wedding Guide, accompanied by a photo of the photographer. The publisher has the final approval of layout, text and photo.
