Explanatory Note: MPD COBALT/Data Warehouse system data as of 1/7/2021. This data represents unrest-related arrests made by MPD in the District of Columbia from 05/30/2020 through the listed date above. An arrest was considered "unrest-related" if it was a curfew violation where a person refused to return home despite receiving a warning, and/or if the person committed another arrestable offense in a public space or due to unlawful entry of a private space, co-located with or near in time or place to demonstrations going on in the city at the time, and appearing clearly or likely linked to the civil unrest in the city. This categorization requires case by case judgment and may be subject to error. Therefore some cases may be added or removed from the list over time. This report should be considered 'Preliminary' in nature due to ongoing data validation procedures. Each row of data represents one person arrested, and that person may have multiple charges in the same arrest, in which case all charges are listed. CCN numbers are based on arrest events, and may be the same for more than one person, if they were arrested as a part of the same event. In cases where juvenile arrests (of individuals under the age of 18 years at the time of arrest) are listed, their names are omitted, unless they were tried as an adult under Title 16. MPD cannot release exact addresses to the general public unless proof of ownership or a subpoena is submitted. Instead, "block of" addresses are provided. Law enforcement partners will be able to obtain exact addresses for official business only.
